NOTICE

As per approval of Chairman/MD, APDCL the following important guidelines for Departmental Accounts Officers' (Promotion) Examination are hereby notified.

1. Examination will be held on a single day (i.e., 14.10.2017)
2. There will be 2 (two) halves for examination. First half will be from 9.30 am to 12.30 noon and second half will be from 1.30 pm to 4.30 pm on Saturday.
3. Each half will consist of 3 papers of 100 marks each. Thus, there will be in total 6 (six) Papers.
4. Pass marks in each paper will be 45% and in aggregate 50% as per prevailing norms.
5. Candidates having exemption on earlier occasions will continue to enjoy the same. For example, candidates having exemption in 1 paper in 1st half will have to score (150-60) i.e., 90 marks to clear 1st half subject, however, to 45% in remaining 2 papers each.
6. In each paper, question pattern would be as follows:
 - i) Answer to Q. No. 1 which is compulsory (2.5X10) carrying 25 Marks. Answer to be given in one sentence only.
 - ii) Candidates have to attempt 3 out of 4 questions carrying (25x 3) i.e., 75 marks. These 25 marks will also have sub group. For instance (10+5) or (5+20) etc.
7. All modes of examination viz., question setting, fixing of invigilators and checking of answer scripts will be assigned to expert agency. No officer from APDCL will be related to examination procedure in any way. Only Managing Director, APDCL and CGM (F&A), APDCL are expected to make spot visit to the venue i.e, AMIE Institute, Panbazar, Guwahati.
8. Lunch Packets will be provided to all examinees.
9. Examination results are expected by first week of November, 2017 which will be hosted in APDCL Website.
10. For the first time in the history of ASEB and its successor companies, detailed syllabus has been chalked out which was prepared by a committee of APDCL Senior Officers and monitored by the CGM (F&A).
11. Two sealed packets of question papers will be supplied by the agency. One packet will be opened in presence of MD, APDCL.
12. For each half, 3 separate Question papers with 3 separate Answer scripts will be provided. Candidates will be free to share time to these papers as per their choice and submit answer scripts as per their choice.
13. All other rules as per prevailing system will stand unchanged.
